The Position

The IT Manager will be responsible for the overall planning, organization, and execution of all IT functions to meet NACCA's organizational requirements. They will lead the IT services department with the primary objective being to facilitate the effective use of technological and productivity tools by the organization in support of NACCA's strategic plan. The successful candidate will also be accountable for ensuring reliable and secure systems administration.

Key Responsibilities

- Plan, organize, direct, and evaluate computer and telecommunications software, hardware, servers, networks, and information systems.
- Create, test, and /or maintain IT security, disaster recovery and business continuity plans
 to ensure minimal impact to the business as well as evaluate and develop current IT
 security policies and procedures.
- Maintain essential IT operations, including operating systems, security tools, applications, servers, email systems, laptops, desktops, software, and hardware.
- Manage IT systems and support staff.
- Manage the IT budget and ensure that all expenditures are within budgetary guidelines.
- Manage vendor relationships, negotiate contractors, and ensure that vendors deliver quality products and services.
